GENERAL INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. SOURCE WATER ASSESSMENT INFORMATION

This water supply obtains its water from the sand and gravel of the Pleistocene aquifer. The Pleistocene aquifer was determined to be susceptible to contamination because the characteristics of the aquifer and overlying materials provide some protection from contaminants from the land surface. The Pleistocene wells will be susceptible to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application.
