RRWA obtained its source water in 2022 from the Chariton River, below Lake Rathbun Dam and directly from Rathbun Lake, both a surface water source a surface water source.

DEFINITIONS

- Maximum Contaminant Level (MCL) – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Contaminant Level Goal (MCLG) -- The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- ppb -- parts per billion.
- ppm -- parts per million.
- pCi/L – picocuries per liter
- N/A – Not applicable
- ND -- Not detected.
- RAA – Running Annual Average
- Treatment Technique (TT) – A required process intended to reduce the level of a contaminant in drinking water.
- Action Level (AL) – The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- Maximum Residual Disinfectant Level Goal (MRDLG) - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- Maximum Residual Disinfectant Level (MRDL) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- SGL – Single Sample Result
- RTCR – Revised Total Coliform Rule
- NTU – Nephelometric Turbidity Units
- LRAA – Locational Running Actual Average

GENERAL INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. Turbidity is an indicator of treatment filter performance and is regulated as a treatment technique.

SOURCE WATER ASSESSMENT INFORMATION

The Corydon Water Supply obtains its water from the Rathbun Regional Water Association, Inc. whose source water in 2022 was the Chariton River after discharge from Rathbun Lake and directly from Rathbun Lake. This is a surface water source. RRWA's Chariton River intake is located below the Rathbun Lake Dam and the Rathbun Lake intake is located directly in Rathbun Lake. An assessment of the watershed has been completed that identifies and prioritizes potential sources of water pollution in the Rathbun Lake watershed that may impair the quality of the raw water for RRWA. These potential sources include wastewater treatment facilities, institutional, retail, and industrial facilities, recreational facilities, residential and commercial areas and land used for agricultural production with characteristics that increase the likelihood of eroded soil, chemicals and livestock waste being carried in runoff to streams, rivers and the lake.
