## GENERAL INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. **The City of New Hampton obtains its water from the Cambrian-Ordovician aquifer. The aquifer was determined to be low susceptibility to contamination because the characteristics of the aquifer and overlying materials prevent easy access of contamination to the aquifer . The City wells will not be susceptible to most contamination sources except through pathways to the aquifer such as abandoned or poorly maintained wells . ### **OTHER INFORMATION**

Infants and young children are typically more vulnerable to lead in drinking water than the general population. It is possible that lead levels at your home may be higher than at other homes in the community as a result of materials used in your homes plumbing. If you are concerned about elevated lead levels in your homes water, you may wish to have your water tested and flush your tap for 30 sec. to 2 minutes before using the tap water. The City of New Hampton is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for cooking or drinking,..If you are concerned about lead in your water, you may wish to have your water tested.
